## Representation of a Woman Character Mira as a Subaltern in Shashi Deshpande's Novel *The Binding Vine*

In cultural theory and post colonialism the term subaltern designates the populations which are socially, politically and geographically outside of the hegemonic power structure of the colony and of the colonial homeland. On describing history told from below, subaltern was coined by Antonio Gramsci, notably through his work on cultural hegemony which identified the groups that are excluded from a society's established institutions and thus denied the means by which people have a voice in their society.

As a method of intellectual discourse, the concept of the subaltern is contentious because it originated as a Eurocentric method of historical enquiry for studying the non-Western people of Africa, Asia, Aand the Middle-East. From its inceptions as an historical research model for studying the colonial experience of the peoples of the Indian Subcontinent, subaltern studies transformed from a model of intellectual discourse into a method of "vigorous post-colonial critique". The term "subaltern" is used in the fields of history, anthropology, sociology, human geography, literary criticism, musicology and art history.

The feminist scholar Gayatri Spivak spoke against an overly broad application of the term in 1992. Subaltern is not just a classy word for "oppressed", for the other, for somebody who is not getting a piece of the pie.

Shashi Deshpande is an award winning Indian novelist. She is a recipient of the Sahitya Akademi Award. Shashi Deshpande has written four children's books, a number of short stories, and nine novels, besides several perspective essays, now available in a voloume entitled Writing from the Margin and Other Essays. Her novels are *The Dark Hold No Terrors* (1980), *If I Die Today* (1982), *Come Up and Be Dead* (1983), *Roots and Shadows* (1983), *That Long Silence* (1989), *The Intrusion and Other Stories* (1993), *A Matter of Time* (1996), *The Binding Vine* (2002), *Small Remedies* (2000), *Moving On* (2004), *In the Country of Deceit* (2008) *and Shadow Play* (2013). In the novel *The Binding Vine* how Mira has been treated in a patriarchal society is drawn here.

Mira, a woman character in Shashi Deshpande's novel *The Binding Vine* was a mother-in-law of Urmila underwent a great humiliation in her husband's house and treated as other. She had suppressed all her feelings, dreams and desires due to the position which was given to a woman in a male-dominated society. The novel explores the aspirations of a woman for her identity but fails in getting it. Mira who aspired to become a poet, did not want to suffer the conventions of marriage and surrender herself to her husband. But all her hopes of becoming a

poet has smashed after getting married, though she was very well versed in writing poems. Even her identity has changed after coming to her husband's house, she was named as Nirmala. How the question of identity has aroused in her mind, she expresses in this poem

A glittering ring gliding on the rice,

Carefully traced a name 'Nirmala'

.Who is this? None but I,

My name hence, bestowed upon mc.

Nirmala, they call, I stand statue-still.

Do you build the new without razing the old?

A tablet of rice, a pencil of gold

Can they make me Nilrmala? I am Mira. .( The Binding Vine-101)

Though she wanted her identity as Mira but it was suppressed in her husband's house as she was treated as a house keep, nothing more than that. So a question comes to her mind which she wanted to ask her mother,

"Mother I always wanted to ask: why do you want me to repeat your history when you so despair of your own? But she died and I will never know her answer now.( *The Binding Vine-* 126)

Even the mother of Mira underwent the suppression in her in-laws house suffered the humiliation of her husband but she wanted to repeat the same history with her daughter. Even the daughter-in-law of Mira underwent the same humiliation. This history goes on repeating in the life of woman. They were treated as weak, other, bearer of children and a working machine so they did not get respect in their in-laws house, though Mira wanted ask her mother a question but her question remained unanswerable as her mother died befor she could ask. If her mother was alive, she could not have done anything to her as women were placed the places of a mother, daughter and wife. So her position in her husband's house was also the same and nothing is going to be changed in her life. Even her mother could not help in her problems, as she suffered the same. The woman has to undergo such humiliation and problems. Women were always suppressed and treated as other and did not get any place in the society.
